## Chair Julie Brownlee opened the public meeting.

The Board reviewed meeting minutes March 8, 2022.

The Board reviewed MV excise abatements of March 17, 2022, totaling \$2,610.38.

The Board reviewed a sewer betterment payoff of March 16, 2022, for 269 South Street, in the amount of \$1,320.00.

The Board reviewed a Chapter land rollback tax for 111 Ball Street, for fiscal years 2018 through 2021, in the amount of \$12,576.23 (including Community Preservation Act taxes and five percent simple interest.) The fifth year, FY2022, was not included in the rollback tax calculation due to removal from Chapter status and full taxation under Chapter 59.

Motion: Chris Reidy moved to approve the chapter land rollback as presented. Seconded: Julie Brownlee Roll Call Vote – Chris Reidy - aye, Julie Brownlee - aye.

Julie Brownlee relayed information regarding methodology for valuation of personal property taxable assets for Verizon accounts, which was presented to assessors by Chris Wilcock, Bureau Chief of the Massachusetts Department of Revenue (DOR), Bureau of Local Assessment. Pending approval from Massachusetts municipalities, Verizon's personal property assets will be taxed according to fixed valuations and depreciation schedules, to which participating municipalities agree to adhere for five years, beginning in Fiscal Year 2023.
