Instructions regarding nomination papers while the town offices are closed to the public:

- Complete the Candidates Request for Nomination Papers
 - o Select the office you are seeking election
 - o Indicate the # of papers you would like to receive (10 is the max # allowed & is recommended)
 - o Indicate whether you want the papers to be mailed to you or if you would like to pick them up at town hall. Please keep in mind that town offices are closed to the public and the Town Clerk's office is working remotely some days. Please plan accordingly.

<u>Deadline to Obtain Nomination Papers:</u> Friday, March 12th at 5:00PM. The Town Clerk's Office will be available until 5PM to issue nomination papers at town hall. You must submit the request via email by 5PM to qualify and papers can be picked up outside of town hall after 5PM.

- Submit your Candidates request for nomination papers to townclerk@town.northborough.ma.us Upon receipt you will receive a confirmation email with information on receiving your papers.
- Receive your nomination papers please allow 3 business days from the date mailed to receive your papers via mail and email townclerk@town.northborough.ma.us if you do not receive them after that. Papers for pick up will be placed in an envelope with your name on it and placed in a designated location prior to your arrival.
- Collect Signatures 50 <u>qualifying</u> voter signatures is required. We recommend obtaining enough signatures, accounting for some that may not qualify and would be rejected. You do not need to fill in the voter's precinct #'s
- **Return Nomination Papers** to the Clerk's Office to be certified Please place your papers in an envelope and drop it in one of the drop boxes outside of the town offices. Kindly email townclerk@town.northborough.ma.us to alert us that your papers have been returned.

<u>Deadline to return nomination papers:</u> Tuesday, March 16th at 5:00 PM. The Town Clerk's Office will be available until 5PM to pick up nomination papers returned from the drop boxes outside of the town offices. Any papers left in the box after 5PM will not qualify.

• **Certification of Papers** – certification of papers must be done in the Town Clerk's office, they cannot be handled remotely, and will be certified as quickly as possible. You will receive an email after certification is completed confirming whether you obtained enough qualifying signatures to have your name placed on the ballot.
