**CALL TO ORDER, OPENING REMARKS, & APPROVAL OF THE MINUTES:** Chair called the meeting to order @ 7:02 PM. She read aloud Gov. Baker's standard advisory regarding public meetings during the pandemic. She conducted a **ROLL CALL** attendance of Bard members present. Director Bruneau will meet with Finance Committee on March 31 to review the budget and any changes. Fuel costs will certainly rise. Will this be handled Town-wide or Department by Department? Next followed a discussion of the e-book distributer Hoopla. Staff are concerned that Hoopla's collection contains, "holdings from publishers that do not align with the Library's collection development policy." Staff will conduct a thorough review of our policy with the aim of retaining more control over choosing our holdings. The Board will be kept informed.

**OLD BUSINESS:** None.

**NEW BUSINESS:** Chair reported that emergency authorization to meet remotely has been extended to July 15, 2022.

The next meeting of the Board will be held via Zoom on April 12, 2022 @ 7 PM.

A motion to adjourn was made by N. Karanjkar (seconded J. Hogan). A **Roll Call** vote was conducted and motion passed unanimously.
