Old Business -

- Meeting minutes from the November 20, 2017 meeting were approved as written.
- Tier II Reporting: Northborough Fire Department (NFD)/ LEPC received 19 submittals for RY2017.
- Hazardous Materials Emergency Planning Grant (HMEP): Funding received went to increase LEPC capabilities as well as improve training of first responders. NFD's FF Doug Pulsifer attended the 2018 International Association of Fire Chiefs (IAFC) Hazmat Conference in Baltimore, M.D. and reported the value in this conference and hazmat education.
- ICS 300 training was hosted in Northborough in October 2017. As a result of a request before the Central Region Homeland Security Planning Council, the Town of Northborough received reimbursement totaling more than \$3,000 for the cost of first responders attending the class.

New Business -

- LEPC Certification is set for renewal August 2019. Prior to this date a comprehensive review, update, and submittal before the Board of Selectmen will take place for their approval.  - Contact Information
 - Chemical Inventories
 - Critical Updates

The presentation concluded with a scenario based exercise where participants utilized the Emergency Response Guide and NIOSH Pocket Guide to Chemicals to identify an unknown chemical, determine initial activation distances, associated threats and medical symptoms.
