BOARD OF SELECTMEN MEETING MINUTES – October 18, 2021

7:00 p.m. - Chairman's Introduction to Remote Meeting

Chairman Perreault stated that this Open Meeting of the Board of Selectmen was being conducted remotely consistent with Governor Baker's Executive Order of June 16, 2021, an Act Relative to Extending Certain COVID-19 Measures Adopted During the State of Emergency and that all members of the Board of Selectmen are allowed and encouraged to participate remotely.

Chairman Perreault noted that the Order allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. He added that ensuring public access does not ensure public participation unless such participation is required by law. Chairman Perreault noted that this meeting will allow for Public Comment only under the Public Comment portion of the agenda. He indicated the various ways that the public may view or participate in this meeting as listed on the posted agenda.

Meeting Business Ground Rules

Chairman Perreault covered the ground rules for effective and clear conduct of the business. He asked members of the Board to mute their phone or computer when not speaking and to speak clearly and in a way that helps generate accurate meeting minutes. He will go through the items on the agenda. Following presentations, Board members will be offered an opportunity to speak, followed by staff members answering any questions, if necessary. Those responding will be asked to wait until the floor is yielded to them. Members were asked if they wish to respond to the comments of others, to do so through the Chair, taking care to identify themselves.

7:15 p.m. - KRISTIN BLACK – HEALTH AGENT COVID Update.

Ms. Black provided a brief COVID update as follows:

Recent Cases and Vaccination Status

The COVID-19 Dashboard Data shows that during the last month, there were 137 positive cases in Town compared to 36 during this same period in 2020. Ms. Black reviewed the breakdown of the vaccination status of 104 of those cases who were aged 12 and older.

Booster Clinics for Adults

The Town recently hosted a Pfizer booster clinic at the Northborough Senior Center and administered 68 vaccines. No additional Pfizer clinics are planned at this time. It is anticipated that the FDA will approve boosters for individuals who received Moderna and Johnson & Johnson vaccines in the coming days. Future Clinics for Children Ages 5-11

It is anticipated the FDA will approve the Pfizer vaccine for children ages 5-11 in the coming weeks. Ms. Black stated that she is closely following the approval process and has already submitted a request for vaccines from the state. COVID-19 Testing

Northborough Public Schools is using Ellsworth McAfee Park for a satellite testing location for the school's Test and Stay Program. This program is for unvaccinated individuals who are inschool close-contacts and is not open to the general public.

Ms. Black confirmed that the Town website will be updated with the appropriate information and links for sign-ups.

7:30 p.m. - APPOINTMENT OF AUDITOR

Mr. Coderre informed the Board that the Town released a Request for Proposals (RFP) from certified public accounting firms qualified to perform municipal audits for fiscal years 2021, 2022 and 2023. Bill Fraher, CPA, the Town's previous auditor for over 20 years will be retiring soon. He noted that while auditing services are considered exempt under the Uniform Procurement Act, the Town chose to move forward with the RFP process to gather competitive pricing from as many qualified firms as possible.

Mr. Coderre noted that the Town received two proposals, one from Scanlon & Associates, and one from Powers & Sullivan, LLC. The proposals were reviewed and ranked by members of the financial team and Chairman Jason Perreault. Mr. Coderre stated that both firms were interviewed by the staff financial team consisting of himself, Finance Director Jason Little and Assistant Town Administrator Becca Meekins. Chairman Perreault was present at both interviews as a representative of the Board of Selectmen.

Following the interviews, reference checks were conducted for both firms. Scanlon & Associates provides auditing services to the Algonquin Regional School District, as well as several surrounding communities, including Westborough, Shrewsbury and Grafton. Northborough has strong organizational and financial ties to the Regional School District, as well as Westborough, Shrewsbury and Grafton through the Regional Veteran's District and the more recent Greater Boroughs Partnership for Health grant. Due to the regional connections, staff believes that working with Scanlon & Associates will be a much more efficient and effective process due to those existing relationships with surrounding communities.

Mr. Coderre recommended that the Board of Selectmen vote to appoint Scanlon & Associates as Auditor for the Town of Northborough for fiscal years 2021, 2022 and 2023. The Board was previously given a copy of the proposal from Scanlon & Associates, as well as a copy of the competitive evaluation form filled out by the financial team.

Jeff Gendron from Scanlon & Associates was remotely present to introduce himself to the Board. Chairman Perreault welcomed Mr. Gendron to Northborough. Selectman Rutan thanked Bill Frayer for his over 20 years of service to the Town.

Selectman Rutan moved the Board vote to appoint Scanlon & Associates, LLC as Auditor for the Town of Northborough, pursuant to their proposal dated September 3, 2021, and to authorize the Town Administrator to execute a contract for fiscal years 2021, 2022 & 2023; Selectman Hirsh seconded the motion; the roll call vote was taken as follows:

7:45 p.m. - SCOTT CHARPENTIER – DPW DIRECTOR

Set Fees for Plowing/Sanding Private Ways for the upcoming 2021-2022 winter season.

Mr. Charpentier proposed to the Board that the base charge for plowing and treatment services of private ways and unaccepted streets which are 100% complete be increased from last year's charge of \$210 to \$215 to cover the costs of labor, fuel and materials, which have significantly increased.

Residents of the private ways that received plowing and treatment services during the last Winter Season were notified of tonight's consideration to increase the fees. No concerns were heard from any of the residents.

Selectman Rogers moved the Board vote to set the fees for plowing and treatment of private ways less than 3,000 feet for the 2021/2022 winter season as follows: \$215.00 per storm per private way for plowing; \$215.00 per storm per private way for treatment; Selectman Rutan seconded the motion; the roll call vote was taken as follows:

Update regarding the Post Occupancy Traffic Study on Bartlett Street.

Mr. Charpentier noted that on September 1, 2021, the Town engaged the Central Massachusetts Regional Planning Commission (CMRPC) to prepare a Post Occupancy Study for the land use located at 330/350 Bartlett Street. He provided a status update as summarized below:

- Crash Analysis Accident data has been collected from both the Massachusetts Department of Transportation (MassDOT) and the Northborough Police Department for the period of time between January 1, 2016 and June 3, 2021. This information has been compiled and is currently being analyzed for inclusion in the final report.
- Intersection Turning Movement Counts On September 23, 2021, vehicles turning movement counts were collected at three locations. Data for the intersections of Bartlett Street and Route 20 and Bartlett Street and Lyman Street were counted manually while counts at the driveway of 330/350 Bartlett Street were collected through automated video analysis. This information is partially compiled and will soon be analyzed for inclusion in the final report.
- Traffic Counts Automated traffic recorders were set at seven locations as previously presented to the Board at the August 16, 2021 meeting. The data was collected from May 17, 2021 through June 1, 2021 and captured all vehicle classes as well as speeds. This data is what supported the Town's request to MassDOT for a heavy commercial vehicle exclusion on Ridge Road and a segment of Maple Street. We are still awaiting a response from MassDOT on this request.
- Pre-Post Traffic Study Comparison The results of the turning movement count at the driveway of 330/350 Bartlett Street show that the total observed trips were 1,719 while the trip projections presented in the February 1, 2015 traffic study submitted to the Planning Board was 2,490.

- Walking Audit All participants will meet at the Algonquin Regional High School on October 28, 2021 where there will be pre-meeting beginning at 9:00 AM. This will be followed by the roadway walk, returning to the School at 11:00 AM where a one-hour post-discussion will be conducted. Approximately 16 representatives have confirmed that they will attend the walking audit, including Town staff from public safety and public works departments, the planning department and the administration office. School staff, a representative from the Planning, Board, representatives from the Central Massachusetts Planning Commission (CMRP) and some facility operators on Bartlett Street will also attend. The next focus group that is invited to participate in the walking audit is interested citizens from the Bartlett Street neighborhood. Mr. Charpentier reviewed the agenda for the walking audit. Both the agenda and a "prompt list" for the various topics will be posted on the Public Works website under "News and Announcements".
- Findings and Mitigation Recommendations Report by the CMRPC The submission of this document along with the supporting data is scheduled for December of 2021.

Following Mr. Charpentier's presentation, the Board briefly discussed the importance of having neighborhood representation in the walking audit as they can bring knowledge that may not be obvious to others. Mr. Charpentier encouraged the Board's participation.

8:15 p.m. - PUBLIC HEARING

Implementation of "Jake Break" prohibition on Bartlett Street, pursuant to Town Code, Chapter 2-44-130 Compression Brake Use Restriction.

Mr. Coderre noted that the Board of Selectmen proposed a new bylaw at the May 1, 2021 Annual Town Meeting. Under Article 39, the Town voted to add a new section 2-44-130 "Compression Brake Use Restricted" to Chapter 2-44 of the Town's general bylaws. The new Section 2-44-130 prohibits the use of engine, compression, dynamic or mechanical exhaust breaks, commonly referred to as "Jake Breaking". He added that on September 7, 2021, the Attorney General approved the bylaw and the Town satisfied the posting/publishing requirements of General Laws, Chapter 40, Section 32.

Mr. Coderre informed the Board that staff is proposing that the Board use the newly approved bylaw to adopt a compression brake restriction for the entire length of Bartlett Street. He added that the Town cannot adopt restrictions on State roads and cannot ban engine or compression braking systems entirely as General Laws, Chapter 90, Section 7 requires these braking systems in certain vehicles.

Mr. Coderre reviewed the proposed location of signs. The signs will make the new bylaw enforceable by the Police Department. He added that the Town will reach out to the facilities on Bartlett Street letting them know that this new restriction is in effect.

In response to questions from Board members, Mr. Charpentier stated that the signs will be consistent with signs posted in other communities and Chief Lyver discussed how the signs will aid in enforcement by the Police Department.

In accordance with the approved bylaw, the Board scheduled tonight's public hearing regarding this matter before voting to approve the recommendation. Chairman Perreault invited comments from the public.

Janeen Callaghan of 6 Stirrup Brook Lane asked about the location of the signs and would they be facing both directions. Mr. Charpentier responded that the intent is to install single sided signs facing oncoming traffic entering Bartlett Street from Route 20, leaving Cedar Hill or Hays Memorial Drive entering Bartlett Street, and signs facing each direction at Lyman Street over by Stirrup Brook Trail. Truck drivers will see a sign as they take a left leaving Lyman Street and they will see a sign as they are coming down the hill on Bartlett Street to take a left onto Lyman Street. Ms. Callaghan asked if a sign can be installed on Lyman Street as trucks are entering Bartlett Street? Mr. Coderre responded that tonight's public hearing is to consider the new bylaw and signage on Bartlett Street only. The Board may consider a request for the bylaw to be implemented on Lyman Street at a future Board meeting.

There were no further comments from members of the public.

Selectman Rogers moved the Board vote to close the public hearing; Selectman Rutan seconded the motion; the roll call vote was taken as follows:

Mr. Coderre explained that any future requests for the implementation of this bylaw in other areas of Town can be considered by the Board at their discretion through a public hearing process. A brief discussion ensued about whether or not it is important that drivers other than truck drivers understand the meaning of the signs. The roll call vote was taken as follows:

REPORTS

Kristen Wixted

- Asked what the Board can do to help retain staff in light of the recent resignation of the Senior Center Director and others over the last one or two years.
- Announced that the 2nd Annual Jack O 'Lantern Stroll will be held at the Town Common on October 30th. Residents can find additional information about the event or sign up to enter their carved pumpkins into the contest by visiting <u>northboroughcac.weebly.com</u>.

- Noted that the Regional School Committee continues to consider the renaming of the High School mascot.
- Noted that the School District sent out a survey to families regarding the use of ARPA funds. Asked if the Town could do the same? Encouraged residents to reach out to her or the entire Board via email to share their ideas. Mr. Coderre noted that the use of the ARPA funds should be considered as part of the normal budget process.

Julianne Hirsh

- Asked that the Board receive regular updates on the status of the ARPA funds so that reasonable priorities can be set.
- Announced that the Cultural Council will be reviewing grant applications soon. Noted that they are looking for new members to serve.
- Noted that the Master Plan Implementation Committee (MPIC) recently met. Their first focus will be to update the mission statement and set some priorities. The MPIC will need an update on the status of the feasibility study for 4 West Main Street. Mr. Coderre responded that there is little doubt that the Town will take the building back in May of 2022. The feasibility study will determine whether the Town should sell the building or use it for municipal purposes. He stated that the Town does not yet control the building. He added that he is working with the current lessee of the building to ensure that the architects and the engineers will have access to the building to evaluate the systems and the state of the building at the appropriate time.

T. Scott Rogers

- Attended 15 meetings or so of those Boards and Committees that he is liaison to since the Board's last meeting in September.
- Echoed Mr. Coderre's message to the Board at the last meeting that the methods for setting priorities for the use of the ARPA funds should be vetted through the established budget process. The Town needs to wait to know what the rules are for use of the ARPA funds in regard to revenue replacement. Asked residents to be patient.
- Thanked Town staff for providing him with details on financial planning and how the ARPA funds may be used under set parameters. Also thanked the DPW Director and Town Engineer for providing details on some of the road and culvert renovations that are ongoing.

Leslie Rutan

- Reiterated that the Town has fantastic staff and when Town staff chooses to depart from their employment it is for a variety of reasons, adding that personnel matters are often not appropriate for public discussion.
- Noted that she agrees with the suggestion by Rachel Armstrong that the meeting packets be provided online to the public prior to the meeting. Mr. Coderre responded that the packet can be made available on the Town website the morning of the meeting.
- Thanked the Algonquin High School for their fundraising efforts for the Northborough Food Pantry.
- Noted that the Diversity & Inclusion Committee held a listening session on September 30th. Thanked Tim Kaelin and the Committee members for the opportunity. She hopes to see another listening session take place at some point in the future.
- Thanked the Health Department for hosting a recent flu clinic at Algonquin High School. Thanked the DPW Department for helping with the set up and breakdown.
- Noted that she has heard that some drivers are confused about the intersection at Route 20 and Patty Lane that leads to the Library parking lot entrance. She asked if arrows could be painted

on the roadway itself? Mr. Coderre reminded the Board about the traffic improvements that were done several years ago to improve the downtown traffic flow. At that time, the traffic engineers originally wanted Patty Lane to be a right-turn out only, but the neighborhood, businesses and the Library wanted it to remain both ways. He will look into whether any improvements can be made through roadway markings or signage.

- Reminded the public that a left turn from Pierce Street onto Church Street is not allowed.

Jason Perreault

- Thanked the Applefest Committee and the volunteers who made this year's Applefest celebration another successful event. Thanked DPW and Public Safety personnel for helping with the event.
- Congratulated Dawn Rand as this year's Applefest Grand Marshall and former Police Chief Ken Hutchins as an Honoree Grand Marshall.
- Congratulated Tougas Farm for being recognized as the 2nd best farm in the State for apple picking by Boston.Com and as the 10th best farm for apple picking in a nationwide poll conducted by USA Today.
- Thanked the Diversity & Inclusion Committee for their recent listening session. This Committee continues to be very active and engaged. He is looking forward to hearing their recommendations at the end of the year.
- Congratulated Northborough resident Mark Donahue for being acknowledged by Best Lawyers as Lawyer of the Year.

PUBLIC COMMENTS

Chairman Perreault stated that the Public Comment portion of the agenda allows for the public to provide input, comments, questions, or concerns. The Board will not engage or deliberate in any detailed discussion, nor will it take action or make any commitments in real time in response to any public comment. If they are able, present Town staff may respond to any questions that can easily be answered. Those who wish to speak under Public Comment will be admitted to the meeting as an attendee and will be asked to provide their full name and address for the record. Public comment will be limited to 3 minutes per person.

Lisa Maselli of 13 Maple Street negatively commented about the following: appearance of the Town, the Board's responsiveness to citizen inquiries, RFP drafting, working with the citizens to create safe streets, misinformation and misguidance of bylaws and lack of follow-up or follow-through.

John Wixted of 2 Stirrup Brook Lane thanked the Town and Mr. Charpentier for installing the safety zone signs and flashing lights.

Janeen Callaghan of 6 Stirrup Brook Lane asked if Bartlett Street neighborhood residents are invited to attend the Waking Audit on October 28th. Mr. Charpentier responded that the Walking Audit is not an invite-only meeting. He suggested that neighborhood residents view the agenda for the various topics that will be posted on the Public Works website under "News and Announcements". Interested residents can just arrive and participate in the walk.

Laura Ziton of 17 Franklin Circle stated that it would be helpful as a resident to have the opportunity to provide feedback on the use of the ARPA funds and what residents would like to see in Town. She would like to see the Board reach out more and listen to the needs of the residents.

APPROVAL AND EXECUTION OF A LEASE AGREEMENT FOR A CELLULAR TOWER AT 119 BEARFOOT ROAD, ASSESSORS MAP 29, LOT 30

Mr. Coderre indicated that when the Town purchased 119 Bearfoot Road back in 2002 for a new Senior Center, there was an existing telecommunications tower onsite with a lease. When the lease expired in 2017, the telecommunications tower reverted back to the Town as the landowner. The Town has been exercising one-year lease extensions since then. At its July 18, 2020 Annual Town Meeting, the Town authorized the Board of Selectmen to issue a bid for a new, long-term cell tower lease and to enter into a lease agreement determined by the Board to be in the best interest of the Town. In June 2021, the Town released a Request for Proposals from qualified wireless communications providers interested in leasing a portion of 119 Bearfoot Road for the construction, installation, operation, and maintenance of a wireless communication facility.

The new lease will include an initial term of twenty (20) years, with two (2) five (5)-year renewal options, for a total potential term of thirty (30) years. The current tower supports telecommunications equipment and holds municipal public safety equipment, including repeaters and antennas. This equipment must stay intact, or be installed on a new tower, if one is constructed, and the Town reserves the right to place additional public safety equipment on the tower at any time.

The Town received two proposals; one from CCATT, LLC to continue to lease the existing tower with the current leases and one from Wireless Edge, a competitor of CCATT, LLC. Wireless Edge's proposal includes a plan to remove and reconstruct the tower at 119 Bearfoot Road. The proposals were reviewed by a staff team including the Assistant Town Administrator, the Public Works Director and the Town Planner.

While the overall price proposal for Wireless Edge is higher than CCATT, LLC, the scoring committee noticed shortcomings with the technical proposal from Wireless Edge. The RFP required specific plans for the replacement of the tower, should the firm propose the removal of the existing tower. The proposer should have submitted a response that clearly denoted an understanding of the current Zoning Bylaws for communications tower installments. The proposal from Wireless Edge contemplates installing an extended tower at 170' to allow for additional carriers, which would require a variance from the Zoning Board of Appeals. The applicant makes no mention of that process, implying a lack of understanding as to what would be required of the firm in the permitting process. This lack of understanding could lead to delays, which puts the Town's income from the tower at risk.

The CCATT, LLC proposal is from a subsidiary of Crown Castle, the current lease holder for the existing tower. The CCATT proposal includes a plan to continue utilizing the existing tower with the existing leases with the current carriers for the foreseeable future. This proposal does not include any plans for reconstruction of the existing tower so there would be no permitting process or delay of income. The CCATT bid guarantees the revenue streams proposed from co-locators as

the subleases already exist between CCATT and the leaseholders. Staff agrees that the most advantageous plan was submitted by CCATT, LLC with a base payment of \$60,000 with an escalation of 5% each year. This amounts to \$4.16 million over the life of the 20-year lease, which is \$1.65 million more than the existing lease that is expiring.

Mr. Coderre responded to questions by members of the Board as follows: The useful life of the telecommunications tower will go beyond the potential 30-year lease; the co-locators are maxed out at the current 4; CCATT, LLC is responsible for maintaining the telecommunications tower and its equipment; and there have been no complaints about the telecommunications tower to date. Selectman Hirsh moved the Board vote to approve and execute the lease agreement and memorandum of agreement, subject to final review as to form by Town Counsel, between the Town of Northborough and CCATT, LLC for the lease of the cell tower at 119 Bearfoot Road in Northborough, pursuant to the proposal submitted by CCATT, LLC on July 28, 2021, for a term of twenty years, commencing November 1, 2021 and terminating on October 31, 2041, with two five-year optional extension periods; Selectman Rogers seconded the motion; the roll call was taken as follows:

I look forward to attending the Board of Selectmen meeting on November 8th to provide a brief COVID-19 update and answer any questions. I will report on recent COVID-19 vaccination clinics. I will also update the Board on case counts and recommendations for upcoming holidays.

Lastly, I will speak to the recent announcement of a Contact Tracing Grant award in the amount of \$160,000 annually for the Greater Boroughs Partnership for Health for Fiscal Years 2022 and 2023.

Description or Purpose of Grant: This grant program is intended to build capacity in local boards of health, ideally through a shared services framework, to be able to fully assume COVID-19 case and cluster investigation, contact tracing, isolation and quarantine support, and associated public health reporting responsibilities starting Q2 of FY2022. Resources will be made available to local boards of health to build epidemiologic, clinical, and community health worker staff capacity to meet these responsibilities as the Community Tracing Collaborative scales down its staff complement between June and September 2021. These resources are expected to be available through June 30, 2023, with any extensions dependent on federal carryforward funds availability.

Only those municipalities or regional planning agencies/regional government councils representing local boards of health listed below are eligible to receive these grant funds. 7. Indicate Grant Scope and Performance Requirements: (include Scope of Service, Performance Measures, and Criteria for Evaluating Responses)

Background:

Response to the current COVID-19 pandemic has required vigorous application of core public health principles and practices. Among these are epidemiologic tracking of laboratory-confirmed cases, identification of close contacts of confirmed cases, investigation of clusters of cases and the contexts of clusters, application of science-based isolation and quarantine procedures, instruction and support for individuals subject to isolation and quarantine, and timely public health reporting. During the period April 2020 through May 2021 the Massachusetts Department of Public Health and local health departments who are the lead public health authorities for these practices have been able to rely, at their discretion and under their authority, on the capacity of the Community Tracing Collaborative to assist with case/cluster investigation, contact tracing, and isolation and quarantine supports.

As rates of completed vaccination against the SARS-CoV-2 virus have grown and daily COVID-19 case volumes have decreased, plans to scale back the staffing of the Community Tracing Collaborative have been operationalized. The Community Tracing Collaborative is slated to end new case investigation and contact tracing efforts by November 30, 2021 and to complete ongoing investigations and contact communications by December 15, 2021.

In order to enable local boards of health, regional planning agencies, and regional government councils and their associated health departments to assume full responsibility for these essential public health practices, the Department of Public Health is making \$5.0M in federal support over the first two years available to selected municipalities, ideally through a shared services framework, to build their epidemiologic, clinical, and community health worker staff capacity to fulfil these responsibilities.

In order to further support the creation and maintenance of share services agreements consistent with the Special Commission on Local and Regional Public Health Blueprint (www.mass.gov/orgs/special-commission-on-local-and-regional-public-health) and the intent of RFR 214333 (Public Health Excellence Grant Program for Shared Services), applicants will be prioritized for funding if they present evidence of having entered into a shared services agreement with at least two other jurisdictions or plan to enter into such agreement as part of RFR 214333. Municipalities eligible to apply under a shared services agreement are limited to: Amherst, Barre, Belchertown, Boylston, Franklin, Douglas, Deerfield, Granby, Greenfield, Hadley, Hardwick, Holden, Leicester, Medway, Millbury, Montague, New Braintree, North Brookfield, Oxford, Pelham, Northborough, South Hadley, Southbridge, Sunderland, Sutton, Upton, Ware, Wayland, Webster, and West Boylston. A selected number of municipalities which have primarily relied on the Community Tracing Collaborative for case/cluster investigation and contact tracing are eligible to apply independently: Brookline, Chicopee, Fitchburg, Newton, Plymouth, Quincy, Randolph, Somerset, and Taunton.

Due to the specific nature of COVID-19 case/cluster investigation and contact tracing, priority will be for the hiring of sufficient epidemiologic staffing to accomplish the scope of service outlined below. Jurisdictions may also expand their public health nursing staff capacity, but

only once their core epidemiologic capacity target has been reached, generally in a ratio of three epidemiologists for every one public health nurse. In order to promote social services coordination to support isolation and quarantine instructions, jurisdictions may use grant resource to create or expand their complement of community health workers.

Scope of Service

Funded entities will expand their epidemiologic staffing, and to the degree necessary their public health nursing and other staff, to accomplish the following public health responsibilities:

- 1. Investigation of 100% of laboratory-confirmed cases of COVID-19 among their residents
- 2. Investigation, with DPH support, of 100% of cluster of cases of COVID-19 among their residents or occurring within their jurisdiction
- 3. Identification of 100% of close contacts as defined by DPH
- 4. Communication by phone, in person, or by electronic means with 100% of cases and close contacts to provide instruction in isolation and quarantine requirements as indicated
- 5. Timely reporting of the status of case/cluster investigation and contact tracing efforts per current public health regulations (105 CMR 300.000) to the Massachusetts Virtual Epidemiologic Network (MAVEN)
- 6. Support for individuals with expressed challenges observing isolation and quarantine instructions, to be coordinated with social services, childcare, nutritional, transportation, housing, mental health, and other practical supports at the local level.
- 7. Conducting of timely and complete analyses of case/cluster data to describe local COVID-19 epidemiology
- 8. Maintaining current staff training and proficiency in MAVEN

Performance Measures

Funded entities will demonstrate on a quarterly basis the hiring, contracting, or progress toward hiring and contracting of sufficient epidemiologic and, as indicated, clinical and community health worker staff capacity to meet the scope of services outlined above, as well as the maintenance of this capacity for the duration of the grant program.

Funded entities will demonstrate through timely MAVEN reporting their fulfillment of the scope of services outlined above. Supplementary reporting of social services support coordination may be required on a periodic basis.

Funded entities will report their expenditures of grant resources on a quarterly basis and justify these expenditures according to the terms of this RFR in order to remain eligible for further installment payments of grant resources.

Criteria for Evaluating Response

Awards will average \$150,000 per year per awardee but will be adjusted proportionally according to the size of the covered jurisdiction(s), their historic and current relative burden of COVID-19, and their risk of COVID-19 due to social vulnerability. Approximately 13 awards across shared services collaboratives and independent municipalities are anticipated. Expected range of awards: \$60,000 to \$400,000.

Proposals will be evaluated according to the following criteria:

- The proposal is complete including all required attachments and forms being received prior to the deadline
- Proposal presents a clear and specific plan for expanding the jurisdiction's epidemiologic staff, and as indicated clinical and community health worker staff capacity (note: existing staffing pattern and any staff expansion under RFR 214333 [Public Health Excellence Grant Program for Shared Services] will be taken into consideration)
- With the exception of those municipalities listed above which may apply independently, entities selected for funding have demonstrated their intent to establish shared services agreements with at least two other local public health authorities
- Proposals have clearly stated their intent and planned capacity to meet the terms of the scope of services outlined above

Applications will undergo two levels of review: Level I Technical Review and Level II Review. Level II review will take into consideration the clarity and appropriateness of staffing plan, commitment to assuming full responsibility for COVID-19 epidemiologic response, and budget.

Based on review scores, Department staff will make recommendations to the DPH Commissioner who makes the final funding determination.

RE: Acceptance of the 2020 RE-PRECINCTING Plan for the Town of Northborough

DT: November 8, 2021

As required by Massachusetts General Law Chapter 54 section 6, the Board of Selectmen is required to vote to accept the 2020 re-precincting plan.

This process occurs every 10 years after the results of the US Census are released. The official 2020 US Census lists our current population at 15,741, a substantial increase since 2010 when our population was listed at 14,155. Although our population increased considerably, we are fortunate that our 4 precincts can still absorb the increase while staying under the maximum 4,000 residents per precinct requirement. Town staff works with our partners at the Census Bureau and Secretary of the Commonwealth to re-draw the precinct lines as needed. To keep our 4 precincts of equivalent size, there will be some minor changes to the borders of each precinct. Given that all Northborough voting precincts are now located at the Melican Middle School, this change will have little impact on our residents. Those voters will be notified of their precinct number change. The attached documents show the proposed new precinct map and current map for reference.

The basis for any redistricting plan is population. The Massachusetts Constitution requires that districts be formed with "as nearly as may be" an equal number of "inhabitants" as determined by the federal census. Municipalities themselves have the initial responsibility of establishing ward and precinct boundaries, which become the building blocks in determining legislative and local government districts.


A precinct is the smallest geographically bounded unit used for state election purposes. A precinct is where one polling place in a municipality is located.

After obtaining the necessary local approval, each city and town must submit their plans, including maps, population information and a legal description of the boundaries of each ward and precinct, to the Secretary of the Commonwealth who thereafter makes this information and material available to an independent commission known as the Local Election District Review Commission (LEDRC).



RE: Redistricting of Massachusetts House and Senate Districts

In conjunction with the reprecincting required after the decennial census, the State Legislature is required to develop a redistricting plan to equalize voting districts due to population changes. The State Legislature has total control over any changes. The proposed plan changes our current representation in the House and Senate and is effective December 31st, 2021.

State Senate: All 4 Northborough precincts will now be in the same Senate district, represented by Senator Chandler. Previously our Senate district was split, 3 precincts in Senator Chandler's district, and 1 precinct in Senator Eldridge's district.

House of Representatives: Northborough residents in precinct 4 will remain in the 12th Worcester District, currently represented by Representative Kilcoyne. Northborough residents in precincts 1, 2, and 3 will now be in the newly created 19th Worcester District.

We will communicate additional information regarding these changes to residents once available, including updated maps.



RE: Ridge Road and Maple Street Heavy Commercial Vehicle Truck Exclusion

As you may recall this past summer, I provided you with some traffic data for the Bartlett Street area as obtained by the Central Massachusetts Regional Planning Agency as part of their annual traffic counting plans within the Town of Northborough. The data indicated the truck traffic on Ridge Road exceeded the minimum 5% required to request an HCVE and I submitted the attached formal application to the Massachusetts Department of Transportation (Mass DOT) for a 24 hour Heavy Commercial Vehicle Exclusion. Also attached is a copy of a letter from Jim Danila, State Traffic Engineer approving the request.

At this time, I would like to request the Board of Selectmen vote to amend the Town Code by adding to Part 9-108-140 (2.5 Ton Truck Exclusions) section E: Ridge Road and amending the current HCVE on Maple Street to include the portion of Maple Street from Ridge Road to Bartlett Street. Once this action is taken by the Board of Selectmen, Mass DOT has indicated they will issue the appropriate permit and the signs indicating the Truck Exclusion is in effect can be installed by the Public Works Department.

24 HOUR EXCLUSION REQUEST FOR HEAVY COMERCIAL VEHICLES ON RIDGE ROAD and a portion of MAPLE STREET, Northborough, MA

Engineering Report for the Massachusetts Department of Transportation

Introduction

As a result of significant Industrial development in the southeast portion of Northborough over the last several years, the Department of Public Works (DPW) is requesting a 24-hour heavy commercial vehicle exclusion (HCVE) for Ridge Road, between Lyman Street and Maple Street and the portion of Maple Street between Bartlett Street and Ridge Road, from the Massachusetts Department of Transportation (MassDOT).

For MassDOT to issue a HCVE for a municipal way, the applicant must demonstrate that a suitable alternate route is available. The alternate route shall have an effective width and pavement structure which can safely accommodate the additional truck traffic. In addition, the alternate route must meet one of the following conditions:

- (1) Lie wholly within the community making application,
- (2) Lie partially in an adjacent community but only on State Highway, or
- (3) Lie partially in an adjacent community but have the adjacent community's written approval.

In addition, one or more of the following warrants may be sufficient justification for truck exclusion:

- A. A volume of heavy commercial vehicles, which usually is in the range of five (5) to eight (8) percent, reduces the utilization of the facility and is cause for a substantial reduction in capacity or safety.
- B. The condition of the pavement structure of the route to be excluded indicates that further repeated heavy wheel loads will result in severe deterioration of the roadway. (Subject to Department review)
- C. Notwithstanding the foregoing, in certain instances where land use is primarily residential in nature and a municipality has requested exclusion only during hours of darkness, a specific night exclusion may be granted.

The Massachusetts Amendments to the 2009 Manual of Uniform Traffic Control Devices, as revised through January 2012, and the Standard Municipal Traffic Code, Part 10 Traffic Regulations, Section 10A-9 Heavy Commercial Vehicle Exclusion, Subsection 2 Data Requires the following information:

- **A.** A twenty-four hour consecutive count of all vehicles using the subject street.
- (1) Commercial vehicles with a carrying capacity over 2½ tons
- (2) Other vehicles
- **B.** Map of the area, with the excluded street marked in red, the alternate route in green.

- **C.** Physical characteristics of excluded and alternate streets in question, i.e, length, width, type and condition of surface and sidewalk.
- **D.** Types of buildings or property abutting street (Residential, Business, School, Playground, etc).
- **E.** Zoning of Street (Residential, Industrial, etc.).
- **F.**Proximity of probable alternate route to the proposed excluded route and the additional distance to be traveled using the alternate route.
- **G.** Types of traffic control existing on street.
- **H.** Hours during which exclusion is to be in effect.
- I. A written statement from the municipality as to the need for the exclusion, and acknowledgement of acceptance of the responsibility for installation and maintenance of appropriate signage.

Required Data

- **A.** See Exhibit A for the twenty-four hour consecutive count of all vehicles using Ridge Road between Lyman Street and Maple Street. The counts were taken at two separate locations 43 Ridge Road and 100 Ridge Road:
 - 1) Exhibit A-1 is the Truck Counts at 43 Ridge Road, for a fourteen (14) day period from 5/18/21 5/31/21 in both directions along Ridge Road. You can see from this information that heavy trucks (2-axle, 6 tire and up) exceeded 5% of the total volume of vehicles on 13 out of the 14 days counted along Ridge Road.
 - 2) Unfortunately, there was an equipment failure during the time the counts were taken in front of 100 Ridge Road and therefore the data is broken up into two periods. The first, Exhibit A-2-a is a two day period 5/18/21 and 5/19/21 where the volume of heavy trucks (2-axle, 6 tire and up) exceeded 5% of the total volume of vehicles on 1 out of the 2 days counted. The second, Exhibit A-2-b is a seven day period where the volume of heavy trucks (2-axle, 6 tire and up) exceeded 5% of the total volume of vehicles on 5 out of the 7 days.
 - 3) Also included is Exhibit A-3 which is the twenty-four hour consecutive count of all vehicles using the portion of Maple Street between Bartlett Street and Ridge Road. The counts were taken in front of house number 115 Maple Street and are provided for a 14 day period from 5/18/21 5/31/21 in both directions along Maple Street. You can see from this information that heavy trucks (2-axle, 6 tire and up) do not exceeded 5% of the total volume of vehicles on any of the days counted although the 14 day average volume of trucks is 3.57%, with a single day maximum count of 4.9% and in reviewing the map you can see there is no place for a truck to exit the neighborhood or turn around on Maple Street due to location of the previously approved HCVE on Maple Street between Route 20 and Ridge Road. We are requesting this portion of Maple Street also be excluded.

- **B.** See attached Exhibit B for a map of the area with the currently excluded streets shown in red, the proposed excluded streets shown in dashed red lines and the alternate routes are shown in green. Please note the counter locations are shown as solid orange blocks. The map also indicates the lengths along each roadway segment.
- **C.** See attached Exhibit C for a table showing the physical characteristics of the excluded and alternate roadways.
- **D.** The types of buildings found along each roadway are also listed in Exhibit B.
- **E.** A current Zoning Map showing the location of the Residential, Business, and Industrial districts is also provided.
- **F.** The table below shows the distance traveled for the excluded and alternate route which are also shown on Exhibit C.

- **G.** Ridge Road is controlled by a stop signs at both the intersection with Lyman Street and Maple Street.
- **H.** The exclusion is requested to be in effect 24-hours a day.
- I. The Town of Northborough is requesting this Heavy Commercial Vehicle Exclusion for Ridge Road and the portion of Maple Street between Bartlett Street and Ridge Road because the width and alignment of this roadway does not allow for the safe passage of two large vehicles traveling in opposite directions and the traffic counts indicate the volume of heavy commercial vehicles exceeds 5% on this portion of Ridge Road. The alternate route which includes Bartlett Street and Route 20 a State Highway which are much more suitable to these types of vehicles.

Exhibit C also indicates the proposed locations of each of the requested signs (R12-3) and the location of the existing No Trucks signs as previously approved for Collins Road and a portion of Maple Street. The signs shall read "NO TRUCKS over 5000 LBS EMPTY WT" and the Town proposes to install four (4) additional signs as shown on Exhibit B.






Attached please find a copy of Senate Bill 499 – An Act Regarding Agricultural Composting Programs. As you know, Senator Harriett Chandler has twice before submitted similar legislation on behalf of the Town. We received late notice of a hearing regarding S499 on November 3, 2021 by the State Legislature's Joint Committee on Environment, Natural Resources and Agriculture.

On behalf of the Town I submitted a letter and testified at the hearing in support of the Bill. I also contacted the Massachusetts Municipal Association (MMA) requesting their support and have been told that MMA Director Geoff Beckwith will be submitting testimony as well.

Anyone interested in providing written testimony in support of this legislation may do so by emailing it to: <u>JointCommittee.Environment@malegislature.gov</u>. Although there is no official deadline, it is generally recommended that written testimony be submitted within two weeks of the November 3rd hearing date.

Despite one of the composting sites in Northborough ceasing to operate on Green Street and the other on Whitney Street being subject to a settlement agreement following legal action by the Attorney General's Office, the root problem remains. Under existing regulations by the State Department of Agricultural Resources, any farm may engage in large-scale commercial composting operations that are exempt from local zoning and landuse regulations. Senate Bill S499 would change that policy.

I look forward to providing a brief update at your November 8th meeting regarding this long-standing legislative priority.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

Chapter 21H of the General Laws, as appearing in the 2018 Official Edition, is hereby amended by striking out subsection 7(b) and inserting in place thereof the following subsection:-

(b) The department of food and agriculture shall establish, in consultation with the department of environmental protection, an agricultural composting program. Said department of food and agriculture is hereby authorized to establish, in consultation with the department of environmental protection, state and local composting projects, and a demonstration agricultural composting program, and to accept applications for grants from municipalities for the purposes of creating agricultural composting projects. Said department of food and agriculture shall promulgate rules and regulations for the operation of state, local, and demonstration agricultural composting programs provided, however, that any such rules and regulations shall require that

- all composting projects and facilities comply with local zoning, land use, conservation, and health ordinances, bylaws, and regulations, including but not limited to requirements regarding
- setback or separation distances, odors, dust and debris, types and quantities of materials, and
- source of materials on-site and off-site, and all such projects and facilities shall comply with
- such local ordinances, bylaws, and regulations.

On behalf of the Town of Northborough's Board of Selectmen we are writing in support of Senate Bill 499 – An Act regarding Agricultural Composting Programs, which was referred to the Joint Committee on Environment, Natural Resources and Agriculture on March 29, 2021.

We write in support of a policy change to regulate large-scale agricultural composting operations that would provide local control over agricultural composting operations in residential neighborhoods. This legislative fix is essential to protect neighbors and their families from the harmful and unpleasant effects of living in proximity to a large composting operation.

Communities in proximity to agricultural composting have been unsuccessful in prior attempts to reconcile disruptions that come with the composting. Disruptions can include volatile odors, fear of contamination of public resources such as water, inability to use public spaces, illness, and an influx of traffic by vehicles too large to be suitable for the neighborhood roads. Unfortunately, under the current regulatory structure, municipalities have little power to address these disruptions.

Empowering municipalities to help their constituents is of the utmost importance, and Beacon Hill must ensure that constituents are provided recourse and protection at the local level. Senate Bill 499 is necessary to ensure that residents are afforded protection by their local government. Agricultural composting operations should not be exempt from local zoning and land-use regulations, or the site assignment process administered by the Department of Environmental Protection. This policy change will ensure that these regulations are put in place.

We strongly urge the Joint Committee on Environment, Natural Resources and Agriculture to support this policy change, and hope to see this fix implemented in the final law.
