Community Preservation Committee Zoom Meeting Minutes March 4, 2021

Chair John Campbell called the Zoom meeting to order at 7:40 p.m. and announced that the meeting was being conducted remotely consistent with Governor Baker's Order of March 12, 2020 due to the current state of emergency in the Commonwealth due to the outbreak of the COVID-19 virus. In order to mitigate the transmission of the virus, we have been advised by the Commonwealth to suspend all public gatherings and, as such, the Governor's Order suspends the requirements of the Open Meeting Law to have all meetings held in a publicly accessible physical location. All members of the CPC were allowed and encouraged to participate remotely. The Order allows the CPC to meet entirely remotely so long as reasonable public access is afforded so the public can follow along with the deliberations of the meeting. This meeting will not feature public comment. The process for the meeting was explained.

<u>Northborough Historical Society (approved 01.07.21)</u> – No action needed. \$20,000 for exterior restoration and preservation of Historical Society building at 52 Main Street White Cliffs Debt Service (vote 03.04.21) \$203,780

<u>Consideration of Minutes (01.07.21)</u> – Mr. Clark made a motion to accept the January 7, 2021 Meeting Minutes; Ms. Milton seconded; roll call vote: Clark-yes; Milton-yes, Harrison-yes; Lelandyes; Campbell-yes; motion approved.

Mr. Campbell said they will once again be going before the town to ask for the debt service for White Cliffs. He would like the Committee to discuss what their role can be going forward on how to present it to the town as to the progress and potential uses for White Cliffs.
