Stephen Madaus (Mirick O'Connell) and Rich Whitehouse were present remotely. With no business to discuss tonight, only peer review interviews, the hearing was continued to a future date. Interview for 425 Whitney Street Peer Review:

Scott Miller, PE, Regional Manager (CES, Inc.) and Eli Port, President (RSSI) were present remotely. Mr. Miller is with Haley and Ward who has been doing municipal engineering work for

121 years. In February they merged with CES, Inc. in Maine for a more in-depth and broader reach for their work. A lot of their work is substantially focused on municipalities. Mr. Miller's peer review clients include Planning Boards, ZBA's and Water & Sewer Departments. This project was of interest to him, but he does not have background information with x-ray radiation and the protection of the systems.

Eli Port, President (RSSI) was having an issue with his audio and, because the board's questions were specific to Mr. Port, this topic was carried over to the August 18th agenda at 6pm but board members will check their calendars and get back to Ms. Joubert if 5pm works with everyone's schedules.
