

TEMPORARY TRAFFIC SAFETY COMMITTEE MEETING MINUTES – December 20, 2022

6:00PM- Scott Charpentier's Introduction to Remote Meeting

Scott Charpentier stated that this Open Meeting of the Temporary Traffic Safety Committee was being conducted remotely consistent with the July 16, 2022 Act Relative to Extending certain COVID-19 measures adopted during the State of Emergency and that all members of the Temporary Traffic Safety Committee are allowed and encouraged to participate remotely. Mr. Charpentier noted that the Order allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting. He added that ensuring public access does not ensure public participation unless such participation is required by law.

1. Election of Officers

Mr. Cohen nominated Ms. Ziton as chair, motion second by Mr. Pierce, unanimously approved by roll call vote.

Mr. Cohen nominated Mr. Pierce as vice chair, second by Chair Ziton, unanimously approved by roll call vote.

Mr. Cohen nominated Ms. Scalise as clerk, second by Chair Ziton, unanimously approved by roll call vote.

2. <u>Discussion of Charge for Temporary Traffic Safety Committee</u>

Mr. Cohen restated the details from the Board of Selectmen meeting when this Committee was originally created. The charge of the temporary traffic safety committee is to first determine if a traffic and safety committee is needed for Northborough based on researching other towns with and without traffic safety committees. If the committee decides a traffic safety committee is necessary, they will identify the type of membership for the committee and what their responsibilities will be.

The Committee will gather data and share their findings at the upcoming meeting.

Committee discussed research criteria and questions to ask towns. The Committee agreed to divide the list of towns and each member would gather the data to be shared at the upcoming meeting.

3. Establishment of schedule
