- **Submit your request for nomination papers** to <u>townclerk@town.northborough.ma.us</u> Upon receipt you will receive a confirmation email with information on receiving your papers.
- Collect Signatures 50 qualifying voter signatures are required. We recommend obtaining enough signatures, accounting for some that may not qualify and would be rejected. You do not need to fill in the voter's precinct #'s
- **Return Nomination Papers** to the Town Clerk's Office to be certified on or before Tuesday, March 12<sup>th</sup> at 5:00 PM. Any papers submitted after 5PM will not qualify.
- Certification of Papers certification of papers will be done as quickly as possible. You will receive an email after certification is completed confirming whether you obtained enough qualifying signatures to have your name placed on the ballot.
